

## **WIN A \$500 TREVI GIFT CARD**

### **CONTEST RULES**

1. The “WIN A \$500 TREVI GIFT CARD” Contest (hereinafter referred to as the “**Contest**”) is organized by Trevi Stores Inc. (hereinafter referred to as “**Trevi**”). Six (6) draws for a \$500 Trevi gift card will be held throughout the year, each on the 4th business day of the month at 10 a.m. following the contest entry period. Any mention of time in these rules refers to Eastern Standard Time (EST). Admission periods and draw dates are defined in the draw section of these rules.

### **ELIGIBILITY**

2. This Contest is open to all residents of Québec aged eighteen (18) or over, and having reached the age of majority in the province where he/she resides, with the exception of all Trevi employees, agents and/or representatives, of affiliated distribution companies or corporations, advertising agencies or any other party linked to this Contest as well as respectively any person living with such employee, agent and/or representative or member of the immediate family. For the purpose of these entry rules, “immediate family” is defined as a father, mother, siblings, child, husband and wife or common-law partner of such employee, agent and/or representative.

### **HOW TO PARTICIPATE**

#### **3. Entry**

When you participate via the survey of satisfaction after a purchase in store, via the satisfaction survey following a delivery\ installation or 1 year following the purchase survey, you will automatically be eligible for our contest. The entrant whose entry form has been selected in the draw will be contacted by Trevi prior to obtaining the Prize (as defined below) and as an essential condition for obtaining it.

**3.1** There is a limit of one entry per person for the duration of the Contest, regardless of the method of entry.

**3.2** No purchase required to enter the Contest.

### **PRIZE**

4. One (1) monthly winner will receive the following prize: one (1) \$500 Trevi gift card that he/she may purchase in one of Trevi’s superstores located in Laval, Blainville, Boucherville, Brossard, Mascouche, Pointe-Claire, Gatineau, Québec City and Lévis (hereinafter referred to as the “**Prize**”).

5. Six (6) prizes are defined for 2025.

**6.** Any prize offered hereby is separately or collectively referred to as the “Prize”.

**7.** Trevi reserves the right, at its entire discretion, to replace the Prize by another one of comparable value if it cannot be awarded to the Winner as described herein for any given reason.

## **DRAW**

**8.** Among the survey entries received, 6 draws will be held during the course of the year and at the beginning of the next, distributed as follows:

- The 1st draw will take place during the first 4 working days of May 2025, covering entries from January 1 to April 30, 2025.
- The next 4 draws will take place on the 4th working day of each month between June and September 2025, covering entries received between the 1st and last day of the previous month.
- The 6th draw, covering entries received between September 1 and December 31, 2025, will be held in the first 10 days of January 2026.

Each draw will be held at the beginning of the month, within 4 business days of the 1st. \* The draw will be handled by Lanla Inc. located at 2060 Peel Street, Suite 902, Montreal, QC, H3A 0J1.

## **GENERAL CONDITIONS**

**9.** To be declared a Winner, the Contestant whose entry ballot was randomly drawn for the Prize must meet the aforementioned entry and eligibility requirements. Should the Contestant fail to abide by one or more of these conditions, he/she will be automatically disqualified and another draw will take place to determine a new winner.

**10.** Limit of one prize per person.

**11.** Only one (1) prize per household.

**12.** Trevi will inform the Winner by private message via the social network used to register for the contest. Should Trevi be unable to contact the selected Winner of one or many draws, for any given reason within forty-eight (48) hours of the draw, Trevi will proceed to as many new draws as required among all entry ballots in order to award the Prize.

**13.** The Prize will be sent by email to the email address provided by the winner.

**14.** The Winner acknowledges that upon Prize delivery, the sole and only guarantee applicable is the one of the manufacturers and/or retailers and/or builders, if any.

related to the Contest (hereinafter referred to as the “Release Beneficiaries”) disclaim all liability regarding the Prize and Contest and give no to such.

**16.** By entering this Contest, the Winner authorizes Trevi to use, if required, his/her name, picture, place of residence, voice, image and (or) statements respecting his/her Prize for advertising purposes and this, without any further compensation. In addition, the Winner agrees that his/her full name and city of residence are posted on Trevi’s Facebook page, Instagram account and on our web site, without any further compensation.

**17.** Trevi’s decisions are final and not subject to appeal.

**18.** The name of the Contest Winner will be available from January 1st through December 31st of each year on the survey homepage and on our web site no later than ten (10) days following the announcement to the Winner.
